Dear Penn Colleagues:

On March 5th, the project hosted the Spring 2021 Information Session, which focused on the Release 1 scope of the project (for more details on Release 1 scope, refer to page [4](#)). Thank you to all those who joined and helped promote the event to your colleagues. We had over 250 attendees and received helpful feedback on how we can better engage with the community for our Fall 2021 Information Sessions.

Other Release 1 milestones include starting Student Records User Acceptance Testing (UAT) in April. During UAT, Penn resources will validate the integrations of the Release 1 systems. Moreover, the team is working to solidify the cutover and go-live details necessary to transition from the current systems to the Release 1 Pennant suite of systems in Fall 2021. To best support the community in this transition, we are developing training and other user support materials.

In addition to the Release 1 efforts, the team continues the design and build for Release 2 Student Records and Financial Aid. We know many of you are excited to learn more about Release 2, and we are looking forward to sharing more about the Release 2 components in the coming months.

As a reminder, the program continues with its Current Systems Freeze period, which limits non-regulatory changes to various current systems. For more information on the Current Systems Freeze period, see page [5](#).

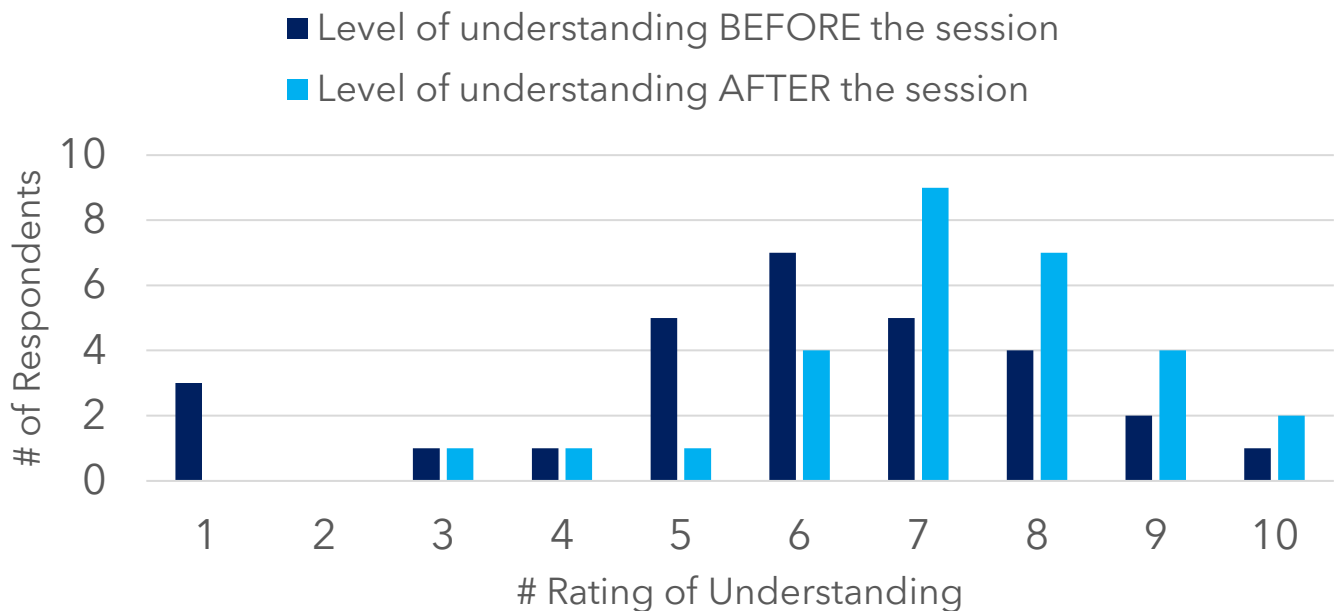

RELEASE 1 STUDENT RECORDS USER ACCEPTANCE TESTING (UAT)

April 2021

Selected participants will assist in validating course conversions to Banner and in testing form functions and integrations in CourseLeaf Section Scheduler (CLSS) and Curriculum Manager (CM).

Participants will test the full lifecycle of a course from proposal in CM through section maintenance in CLSS.

RELEASE 1 STUDENT RECORDS DRIP TRAINING

Spring 2021

DRIP is a training material roll-out strategy which gradually cascades information to end-users in preparation for formal training sessions.

DRIP will begin the second week of April and continue throughout the Spring to prepare users for training sessions in the Summer. DRIP content will include overviews about Curriculum Manager (CM), CourseLeaf Section Scheduler (CLSS), and other Release 1 functionality.

TRAINING SESSIONS

Summer & Fall 2021

Release 1 Student Records training for users will take place in Summer 2021, focusing on CM Retrofit and CLSS:

- CM - Learn what functionality has been added, modified, and removed
- CLSS - Learn the section maintenance process, including creating and maintaining sections

Release 1 Pennant Aid training for end-users will take place in Fall 2021, focusing on Banner, enhanced ImageNow functionality, Pennant Reports, and more.

NGSS Systems - Release 1 Scope

What is Pennant?

The Next Generation Student Systems (NGSS) program is deploying Penn’s new student information system, referred to as the Pennant suite of applications. Pennant Accounts (student accounts and billing) has been live since 2015. Additional components of this suite include Pennant Records (student records and registration) and Pennant Aid (student financial aid), which will go-live in Fall 2021 (Release 1) and Spring 2022 (Release 2).

The NGSS program continues to design, build, and configure future-state systems supporting our [student records](#) and [financial aid](#) processes. The systems included in NGSS Release 1 will start to be used in Fall 2021 based on when academic or business processes launch (e.g. course and section maintenance, financial aid packaging).
